The performance evaluation period for this round is from **January 1, 2023, to December 31, 2025.**

Applicants are advised to update information in the Teacher Performance System in advance.

- (2) 獲「新聘特殊優秀人才辦法」獎勵者若於期滿前申請本獎勵，僅得採計任職本校專任教師期間之資料，獲獎勵後新聘特殊優秀人才獎勵所餘期間自動失效。(新聘特殊優秀人才辦法規定)
- (3) 被借調人員不得於同一期間重複領取原任職機構及借調單位之研究獎勵金。(國科會規定)

1. Applicants shall gain the following qualifications.

- (1) Certified NTNU full-time faculty members who have received an average score of 3.5 or above in the Student Opinion of Instruction Survey during the year before application (does not apply to newly appointed faculty members)
- (2) For recipients of "Newly Appointed Distinguished Talent Incentive" who are still in the incentive period and apply for the "Distinguished Talent Incentive", only performance data during their employment as certified faculty member at NTNU can be calculated. After receiving Distinguished Talent Incentive, the remaining period of the Newly Appointed Distinguished Talent Incentive will be invalidated.
- (3) Seconded faculty members shall not receive research incentives/rewards from both NTNU and their seconded organization during the same period.

Whether the textbook, annotation (translation) books, and other books with different attributes meet the requirements of academic books shall be confirmed by NTNU Press before submission for review.
